Meeting called to order at 7:04 p.m.

Meeting Minutes from December 14, 2010 were read. **Motion:** A motion was made by Mrs. Wood and seconded by Mrs. Goodwin to accept the meeting minutes with minor corrections. **Vote:** Affirmative – Unanimous

Financials: The Commission reviewed monthly financial paperwork.

Gunstock Outreach: The first night of lessons went well. Lonergan noted all participants in our program wear numbered bibs so they are easily identified.

Basketball Updates: The season is well on its way. All teams are now playing against other area towns. Tim Snow is reffing all the games. Goodwin noted that Snow is doing a great job. Lonergan noted that holding the games on Saturday at the WRMS is wonderful. Discussion regarding the sizing of the 5th & 6th grade girl's two teams was held. Each team has only eight players. It is great to have smaller teams however the drawback is that if some girls cannot make a game, it puts the team at a disadvantage. Lonergan will allow girls from one team to join the other team if needed on a rotation basis and if they are available.

Ice Skating: This year's skating is very well attended. Lonergan will work with the Pines C.C. on having a sign-in to capture who is utilizing the program. Also Lonergan will post signs for the time breakdown. Enforcement of the time is critical to preserve the family skate time. Lonergan will send a notice thru the e-mail list with an outline of the ice skating program.

B&A Program: Lonergan updated that the storage unit/ shelving approved at last month's meeting was not needed after all. Lonergan also updated that she was working more mornings at the program to help with payroll.

Town Park Conceptual Master Plan: The Commission requested Lonergan to set-up a meeting with the BOS to ask for approval of the Town Park Conceptual Master Plan. The Commission will also be seeking a request for a warrant article to implement Phase One of the plan for the 2011-2012 budget cycle. The Commission discussed that last year the BOS suggested bringing a warrant for this year budget cycle of 2011-2012. The Commission agreed that in these economic times that it would be difficult but the Commission felt it needs to be documented, so when the time is right the project is not overlooked. It was discussed that we have not received any feedback regarding submission of Phase One to the CIP Committee. Lonergan will request either January 19th or January 26th and will inform the Commission which date the BOS have room on their agenda.
