**Meeting Minutes:** from April 10<sup>th</sup>, 2012 were read. **Motion:** A motion was made by Mrs. Goodwin and seconded by Mr. Cray to accept the meeting minutes. **Vote**: Affirmative – Unanimous.

**Snack Shack Refit:** Lonergan updated that the snack shack refit is completed and ready to be used. Cray noted that he had witnessed vandalism at the Park and had called the Police. The police did respond and handled the matter. Lonergan did follow up and was seeking community service for actions taken. At this point Lonergan updated that nothing had been set up. The Commission would like Lonergan to follow up again. The Commission discussed the possibilities of cameras; Lonergan will get more info for Junes meeting.

**Soccer Grant**: Lonergan asked the Commission to accept a sponsorship from: ChevyBENSON AUTO CO., INC. would like to sponsor Sanbornton Rec Soccer for the Fall 2012 season through the Chevrolet Youth Soccer Program. As part of the program, your local Chevrolet dealer will support your organization by donating a sponsorship package consisting of soccer equipment and a \$500 cash contribution. **Motion**: A motion was made by Mrs. Godwin and seconded by Mrs. Wood to accept the sponsorship form ChevyBENSON AUTO CO., INC. **Vote**: Affirmative – Unanimous.

**B&A Program:** Lonergan and Elliott followed up with a suggested language change to the hand book: (Late Fee: Please be aware that \$1.00 per minute is charged to anyone picking his or her child up after 5:30 p.m. This rule is strictly enforced. After 5 late pick-ups in the school year, your child will to not be allowed to attend the program for one week. If your child returns to the program and the late pick-ups continue your child will be removed from the program). After discussion the follow changes were approved for the handbook. Late Fee: Please be aware that \$1.00 per minute is charged to anyone picking his or her child up after 5:30 p.m. This rule is strictly enforced. After Three late pick-ups in the school year, your child will to not be allowed to attend the program for one week. When you return to the program if there are TWO additional late pick-ups you B&A privileged will be terminated for the remainder of the school year. If you wish to return the following year an approved correction action plan will need to be in place.

**T-Ball:** Sign ups surged at the end and we now have three teams, twenty seven players. This year's sponsors BarnZ's Cinema, Steele Hill Resorts and Sanbornton Fire Relief. Coaches are in place and t-shirt and hats are on order. Smith asked if all coaches had criminal background checks. Every five years a renewal will be required. **Vote:** Affirmative – Unanimous.

**Tennis Lessons:** Lessons are being offered in June and July at the Winnisquam High School courts. Starting Wednesday evenings, June 20<sup>th</sup> thru July 25<sup>th</sup> no class on July 4<sup>th</sup>. 5:00-6:00 p.m. 5-9 year olds, 6:00-7:00 p.m. 10-14 year olds, and 15+ 7:00-8:00 p.m. Cost is \$50.00 for all five lessons. The instructor this year is Phillip Eisenmann.
