Lonergan will contact WRHS Student Council and ask for assistance in hiding the eggs. Lonergan made a proposal to hold a second hunt, a "Flash Light Egg Hunt" for older kids. Discussion regarding location, time, when and who would attend. The concision was to hold the hunt on Saturday, March 23<sup>rd</sup> 7:30pm in the town field behind the Town hall, Church and Library for children in grades 4<sup>th</sup> -6<sup>th</sup> and that younger children could attend as long as a parent/guardian accompanied them during the search.
