Meeting Minutes: A motion was made by Cray and seconded by Goodwin to accept the meeting minutes as read for the September $13^{\text {th }}$ meeting Vote: Affirmative - Unanimous. The minutes from October $11^{\text {th }}$ were reviewed. A motion was made by Cray and seconded by Goodwin to approve the minutes with corrections. Vote: Affirmative- Unanimous.

Financials: Monthly financials sheets were reviewed for October. Adult Men's Basketball: The program is up and running with several registered players.
B\&A School: Program doing well. Lonergan updated that the September numbers were not calculated but will have at the next meeting.

Fall Field Hockey end the season with a floor hockey game at SCS. It was a fun way to end the season.

Fall Soccer ended on the $29^{\text {th }}$ of October which was a cold and rainy day. The prior weekend due to bad weather the $4^{\text {th }}-6^{\text {th }}$ grade jamboree was cancelled and we were not able to make it up. Lonergan stated that next year she will try to have the jamboree in the beginning of the season to avoid this happening again.
