WHEREAS, the Planning Board reviewed a	nd commented on the Certificate of Zoning

to authorize the processing of the Certificate of Zoni	ng Compliance permit application;
WHEREAS, the Town will issue or has issu	ed a Certificate of Zoning Compliance

**NOW THEREFORE**, said Owner, on behalf of himself, his heirs, legal representatives, successors and assigns, does acknowledge and agree that the Road is either a private right-of-way, or a private road or a Class a Class VI highway and further agrees that the Town has no legal duty to maintain the relevant portion of the Road and that the Town neither assumes responsibility for maintenance or repair, including snow plowing, nor liability for any damages resulting from the use of the relevant portion of the Road;

Owner shall be responsible for maintaining access to the subject property, including snow plowing, and shall assume responsibility for transporting any child to and from the nearest designated school bus stop; and does hereby forever release and discharge the Town, its officers, agents and employees from the obligation of maintaining the relevant portion of said Road and from any claim of any nature, whether in tort or otherwise, which Owner might have against the Town for any loss or damage, including those incurred through failure to provide municipal services including police, fire and ambulance services;

**FURTHER**, the Owner(s) will defend, indemnify and hold harmless the Town of Sanbornton, its officers, agents or employees against any and all claims, demands, costs and judgments arising from the use of the private right-of-way, or private road or Class VI highway.
